## National Missing Children's Day Poster Contest

Each year more than 1.3 million children are reported missing. Law enforcement, citizens and even children have been instrumental in keeping children safe and returning them home to their families, communities and schools. Every year, the U.S. Department of Justice (DOJ) takes time to commemorate the valiant and unselfish acts of the many organizations and individuals who bring our missing children home. On May 25, 2015, National Missing Children's Day, we will pause to focus our attention on children who have been recovered, as well as the children who are still missing.

As part of the annual commemoration, DOJ sponsors a national poster contest and announces the winner at the annual National Missing Children's Day ceremony in Washington, D.C. The winner of this national contest, along with his or her teacher and parents, are flown to Washington to attend this special ceremony. Everyone is invited to join us in our efforts to educate children across the country about safety issues by giving your fifth-grade students an opportunity to participate in this poster contest. Local schools participating in the event will have the opportunity to submit their winning poster for judging at the state level. The Florida Department of Law Enforcement's Missing Endangered Persons Information Clearinghouse (MEPIC), along with the Florida Department of Education and other organizations, will be working together to select a winner to represent the state of Florida. The statewide winner will receive an all-expenses-paid trip to Tallahassee, Florida, for Missing Children's Day in September 2015. The winner will also receive a prize package, including a trip to Universal Studios, and his or her poster will be submitted to the U.S. Department of Justice for national judging.

The theme for the poster contest is "Bring Our Missing Children Home." Submissions must be handcrafted and measure 8  $\frac{1}{2}$  x 14 inches. We suggest that schools start as soon as possible on school-level poster contests and classroom discussions. Those schools interested in participating are asked to submit their poster(s) for state-level judging, postmarked by February 16, 2015, to the following:

# **Looking for ways to decrease traffic to the clinic?**

Oftentimes, many health complaints can be addressed in the classroom with minimal disruption to the learning process:

- Students with stomachaches can be sent to the restroom.
- A student with a headache can rest their head on their desk for 10 minutes.
- Many students visit the clinic requesting ice and have no visible signs of injury. If the classroom teacher did not witness an injury and there are no visible signs of injury the student should not be sent to the clinic, as many students use the opportunity to wander around. Also, if anyone witnesses an injury that warrants medical attention the witness should initiate the injury report.
- Students needing a Band-Aid for an old injury or paper cut can be handed one in class.
- Per the head lice policy, head checks should be done only on students who are symptomatic.

Since many schools do not have a full-time health services person on campus every day, taking these small steps can help to decrease the amount of clinic traffic every day, and help to also lessen the strain on the front office staff that help to cover the clinics.

The clinic should be a temporary place for students to rest if they are not feeling well enough to be in class. The main reasons for sending a student home are: vomiting more than twice or vomiting with other symptoms of illness, diarrhea, fever greater than 101, and a generalized rash of unknown origin. It is also important for school staff to notify the parents of any student who is chronically complaining of illness and requesting a regular visit to the clinic. In these cases, over-the-counter medication can be brought in for headaches and stomachaches that are chronic, and the school nurse can assist with investigating other causes for the chronic complaints.
