Response: Cross Bayou Elementary School will maintain a system to provide parent resources, as well as inform others of their availability. We are working together with parents to update email contacts in Focus and work with teachers to support teacher-parent communication via email. We will use the weekly phone call/email message to remind parents of events and upcoming school activities. We also keep parents informed through our newsletter. We utilize agenda books and a weekly communication folder for each student in order to increase parent/teacher communication. Teachers can notify parents of homework, class assignments, test days and other information in the agenda book. We send home flyers and other communications to parents every Wednesday in the communication folder. Our teachers will make at least 1 positive phone call home to each family in their class prior to school starting in August. They will also make at least 1 positive phone call home at least once a month for each student to continue to build relationships with our families.
