Prepare your documents

- Your ID
- Your social security number
- Your permanent resident card (if you are not a citizen)
- 2023 W2 Forms
- 2023 tax records

You will need the same information for your parents if you are a dependent student (24 years or younger).

Create you FSA ID

This will be your electronic signature to your FAFSA. It is your way to log in to your application and access to various websites related to federal student aid.



If you are a dependent student, your parents will need their own FSA ID and must also electronically sign the application for it to be complete. Sign and submit your application-Dependent student applications must have parent signature.

To be Elgibile to receive federal student aid, you must:




- Be a citizen or eligible noncitizen of the United States.
