Bottoms	Shirts	Unacceptable
 <p>Solid Color Pants/Jeans <b>ONLY!</b> Khaki, Navy, or Black Joggers, Cargo Pants or shorts are allowed. Pants <b>MUST</b> be secured at the waist, belts buckled, no underwear exposed. <b><i>Must wear a belt.</i></b></p>	 <p>Any color polo style shirts <b>ONLY! All shirts MUST have a collar.</b></p>	 <p><b>No tights, leggings, or spandex. No gym wear</b> (ex. Gym shorts, tank tops, jerseys, sweat pants, etc.). <b>Pants cannot have holes or tears.</b></p>
 <p>Any Solid Color Shorts (No shorter than 3 inches above the knee), Skirts/Skort, Carpris, Uniform Dresses or Jeggings with pockets are allowed in solid colors only.  The length of shorts, skirts or dresses must be <b><u>knee length or longer.</u></b></p>	 <p>Lealman T-Shirts can be worn any day of the week.</p>	 <p>No head wear (ex. Du-Rags, scarfs, hats, or sports bands, sunglasses) <b>Absolutely No Hoodies</b></p>
<p>JACKETS/SHOES and other garments:</p> <p><b>JACKETS:</b> Jackets <b>ONLY without hoods!</b></p> <p><b>SHOES:</b> Closed toes shoes (e.x. tennis shoes) or sandals with a strap.</p>		 <p>No Sleepwear, pajamas, swimwear or boxer shorts worn as outer garments <b>Absolutely no slides or flip-flops.</b></p>

<p><b>Dress code infractions</b> will be:</p> <ul style="list-style-type: none"><li>• Corrected</li><li>• Referrals written and learner will be returned to class.</li><li>• Learners will be required to change into clothing provided by LIA, clothing must be returned.</li><li>• If a learner refuses to change or removes correction – the learner’s parent will be called to provide/bring appropriate clothing or they will report to P.A.S.S. for the remainder of the day and a Restorative Conference will be <b><u>Required</u></b>.</li></ul>	<p>Dress code serves as an:</p> <ul style="list-style-type: none"><li>• Encouragement to learners to dress in good taste and present a general appearance that is commendable and presentable in both the school environment and the workplace.</li><li>• Deterrent to prohibit clothing or adornment that disrupts the educational process.</li><li>• Measure of safety which prohibits dress that constitutes a potential safety or health hazard for the student or the school environment.</li></ul>	<p>The following items have potential to cause disruptions or threats to a safe and positive school environment and are not allowed to be worn on campus during the school day (from arrival on campus until the student exits to the outer perimeter of the building):</p> <ul style="list-style-type: none"><li>• Hoods and sunglasses.</li><li>• Chains hanging from the neck, belt, pocket or attached to wallet.</li><li>• Jewelry that contains any type of sharp objects.</li></ul>
<p><b>1st Offense</b> – Warning, phone call to parent <b>2nd Offense</b> – After school detention, Uniform Contract, phone call to parent <b>3rd Offense</b> – Individualized</p>
