All accommodation requests should be submitted by your school official by the published registration deadlines on the front of this form.

Requesting Accommodations for ACT

1. Register for the ACT test
 - Indicate need for accommodations
 - Select the type of accommodation you need
2. Return this form to Ms. Forbes in the Media Center so the request can be submitted.
3. **Your school official will submit your request to ACT.** ACT will review the request and email the Accommodations Decision Notification to your school official. Your admission ticket will indicate what accommodations if any you have been approved to receive.

Requesting Accommodations for College Board- PSAT, SAT or AP Tests

1. When register for the SAT test
 - Indicate need for accommodations
 - Select the type of accommodation you need
2. Return this form to Ms. Forbes in the Media Center so the request can be submitted.
3. **Your school official will submit your request to College Board.** They will review the request and email the Accommodations Decision Notification to your school official. Your admission ticket will indicate what accommodations if any you have been approved to receive.
