We are looking forward to our upcoming Homecoming Dance with your student(s). We want to be sure that you and your student(s) are aware of our expectations for appropriate behavior while at the event. Students are expected to conduct themselves in a way that will, at all times, be a positive reflection on their family, PHUHS and the group they are representing. Please review the information below and bring this signed behavior contract to Mrs. Tancrell outside of the TA to get your access code to purchase a ticket. Tickets will go on sale August 28th – September 8th online only on Gofan.co. There are a limited number of tickets for the event.

If this contract is not returned in person to Mrs. Tancrell, the student may NOT be permitted to participate in the event. Questions can be emailed to tancrellk@pcsb.org.

Please initial the following statements indicating that you understand the following policies.
(initial) Homecoming Dance Ticket payment MUST be made online @ Gofan.co. This signed Behavior Contract and Guest Application (if applicable) MUST be brought to Mrs. Tancrell outside of the TA during both lunches from August 28th - September 8th or after school. No emails accepted.
(initial) <b>Homecoming Dance Ticket payment MUST be made online @ Gofan.co by September 8<sup>th</sup>.</b> Obtaining a Gofan.co access code DOES NOT mean you have a ticket until you purchase it online. <b>NO tickets will be sold after September 8<sup>th</sup>.</b>
(initial) PHUHS students are required to complete and submit a <b>Homecoming Guest Permission Request</b> and submit it to their grade level secretary for administration approval. You must pick up your <b>APPROVED</b> form prior to getting an access code to purchase a guest ticket. <b>No middle school student or person over the age of 20 may be a guest</b> .
(initial) Once a ticket is purchased there are <u>NO REFUNDS</u> given for any reason (Including, if a student is not allowed to attend due to disciplinary reasons, failure to complete required paperwork or failure to attend the event). <b>Students are not allowed to exchange or resell tickets.</b>
(initial)Students MUST have their Student ID, License or access to their Focus Page along with their valid ticket to enter the dance.
(initial) I understand and agree that my students will abide by the student code of conduct event rules and regulations.
<b>Expectations for Behavior</b> : Students will be supervised by the faculty sponsor and the other adult chaperones. Students are expected to follow the Pinellas County Schools <i>Code of Student Conduct</i> at all times. Any violation of the <i>Code of Student Conduct</i> will result in disciplinary action that could restrict participation in commencement activities.
<ol> <li>The following <i>General Guidelines for Field Trips and Events</i> will be strictly enforced:         <ol> <li>Students attending the Homecoming Dance MUST arrive on time. No students will be allowed into the dance after 8pm. Students who do not arrive on time will not be allowed in and NO refunds will be issued.</li> <li>All individuals attending the event could undergo a metal detector screening before entering the dance premises. This security measure is intended to ensure the safety and well-being of all attendees.</li> <li>Once inside the event no one is allowed to leave and return for any reason.</li> </ol> </li> <li>Students are not permitted to purchase, consume, or be under the influence of tobacco, drugs, or alcohol at any time. This includes Juuls and other vaping products/devices. Violators will be subject to serious disciplinary consequences.</li> <li>Students are not permitted into any restricted or unauthorized areas. If found in restricted/unauthorized areas, students will face disciplinary action.</li> <li>Students WILL NOT be issued a refund if they are not allowed into the dance or if they are removed for a violation of any part of this contract/any reason deemed appropriate by a faculty member of Palm Harbor University High School.</li> <li>I understand that I MUST make arrangements to be picked up no later than 15 minutes (10:15 P.M.) after the dance ends. I also understand that a consequence may be administered to any student remaining after the 10:15 pick up time.</li> <li>Party buses, limousines, and/or personal vehicles MAY be subjected to searches without cause.</li> </ol>
