Candidates must attend a Pinellas County public middle or high school and have the aspiration to attend college or technical school but not the financial means.

Proof of eligibility will be reviewed with the application.

Take Stock in Children Scholars receive:

A Scholarship – a tuition-only Florida Prepaid College scholarship which can be used at any university, college or vocational/technical school that accepts financial aid. (value is up to 120 credit hours at state college rate)

A Mentor – a volunteer mentor who will meet with your child bi-weekly virtually or at school, to assist and encourage your child to achieve their highest potential

A College Success Coach – a Take Stock staff person who will help your child design a college success plan and guide them through middle and high school and transition into college.



of our scholars graduate from high school compared to an average of 87% in Florida and 72% for non-TSIC peers

of our scholars <mark>enroll in college</mark> compared to an average of 74% in Florida and 35% for non-TSIC peers

of our scholars graduate from college compared to an average of 51% in Florida and 17% for non-TSIC peers

Students must be enrolled full-time in a Pinellas County School and be in the 6th through 9th grade at the time of the application.

ELIGIBILITY AND REQUIRED DOCUMENTS

Students may qualify by one or more of the four financial eligibility options below:

OPTION 1: Recipient of Free and Reduced Lunch **PLUS** meet USDA Income Eligibility Guidelines, income chart on front, and provide a Free and Reduced Letter <u>plus</u> first two pages of 2020 income tax return that shows student applicant name as a dependent, both Free/Reduced Lunch eligibility and income guideline must be met for this option (see example)

OR

OPTION 2: HUD Documentation, income chart on front, and provide current HUD Eligibility Letter - student name <u>must</u> appear on HUD letter]

OR

OPTION 3: Medicaid Recipient Documentation [provide CURRENT Medicaid eligibility verification document - student name MUST appear on document)

OR

OPTION 4: SNAP or TANF Recipient Documentation [provide CURRENT SNAP or TANF eligibility
