WHAT DO I NEED TO KNOW?

For 2025, we continue to provide you with quality, affordable benefit plans that meet your needs and those of your family. Here are the highlights:

Health Plans: In 2025, our health plan is expected to reach \$154 million, an increase of \$10.5M (7.4%) from 2024. Overall, 80% of the health plan costs will continue to be covered by the district and 20% by the employees, with some increases in premium and plan design changes. Review the **Annual Enrollment Flyer** for specific details on these changes.

Pharmacy Plan: Review the **2025 Aetna Standard Plan Formulary** for any formulary changes effective 01/01/2025. In addition, certain GLP-1 weight loss medications may be subject to a 25% cost-share. Criteria applies and does not apply to out-of-pocket maximum.

Healthcare Flexible Spending Account Maximum Increased: The healthcare flexible spending maximum increased to \$3,000 for 2025.

Dental, Vision, Life, Disability and Hospital Indemnity Plans: Rates have been renewed for 2025 with no plan changes or rate increases.

A New Virtual Care Network (Primary and Immediate Care) was introduced on September 1st (may be subject to deductible or copay depending upon your plan). Aetna will no longer offer Teladoc as of January1, 2025.

Employee Assistance Program (EAP): A new Lifestyle Coaching Program will be offered January 1st through Resources for Living (resourcesforliving.com - username pcsb, password eap) or by phone 800-848-9392.

Actions You May Need to Take as of January 1, 2025

Flexible Spending Account (FSA) Notices and Deadlines

If you were enrolled in a Flexible Spending Account or Health Reimbursement Account for 2024, you have until December 31st to use those funds. You may submit receipts for services in 2024 up through March 31, 2025. Balances left over will be forfeited and used to offset the expenses of the plan. Visit our **Flexible Spending webpage** for a claim form and answers to frequently asked questions. Visit Inspira's website for eligible expenses: **Inspira FSA login site**.

Please Note: Employees enrolled in an FSA or HRA during 2024, and fail to provide required documentation by March 31, 2025, will have the total unsubstantiated amount reflected in their 2025 W-2 as taxable income. Once the amount is included in the employee's W-2, Inspira will reactivate their debit card, and the employee can begin using the card again (if enrolled in 2025).
