<u>The Meaningful Notice Plan</u> Information provides a brief explanation of the provisions, policies, and rules that govern our voluntary retirement plan. Most employees are eligible to participate in the 403(b) and 457(b) plans immediately upon employment; however, private contractors, appointed/elected trustees and/or school board members are not eligible to participate in the Retirement Savings Program. Eligible employees may make voluntary elective deferrals to both the 403(b) and 457(b) plans and participants are fully vested in their contributions and earnings at all times.
