## EDUCATIONAL INTERPRETER FOR DEAF/HARD OF HEARING I - PROVISIONAL

#### **QUALIFICATIONS:**

Graduation from a standard high school or possession of a GED. Knowledge of basic signing. Must pass a basic sign language screening conducted by an instructional or administrative representative from the Deaf/Hard of Hearing Program. Minimum of one year educational or community interpreting.

#### **MAJOR FUNCTION**

Provides sign language interpreting for students who are deaf or hard of hearing (as documented on their IEP's), based on the preferred language of the individual consumer. This will occur in basic, slow-paced interpreting situations where there are frequent opportunities to ask for repetition or clarification and no complex terminology or concepts are included.

#### **ESSENTIAL RESPONSIBILITIES**

- Provides receptive and expressive communication access for students who are deaf or hard of hearing through interpreting, as indicated on their IEP's, in both academic settings and at schoolrelated activities.
- Supports opportunities for students who are deaf or hard of hearing to fully participate in classroom discussions and social interactions.
- Serves as a language model for students who are deaf or hard of hearing for oral and signed communication.
- Provides student support, under the direction of the classroom teacher, by previewing or reviewing classroom instructional information.
- Shares relevant information about the DHH student's classroom performance, communication needs and social/emotional functioning with appropriate members of the educational team in a professional and objective manner.
- Participates in IEP meetings as an active member of the IEP Team.
- Collaborates with school staff to support the appropriate delivery of IEP accommodations.
- Establishes and maintains positive and professional relationships with all stakeholders.
- Establishes, in conjunction with the appropriate stakeholders, a physical setting (lighting, noise level, distance, line of sight) that promotes effective interaction and communication.
- Prepares for interpreting assignments, when possible, by acquiring, reviewing and researching topics/materials to being covered.
- Performs all job duties under the guidelines of the Registry of Interpreters for the Deaf/National Association of the Deaf (NAD-RID) Code of Professional Conduct and the EIPA Guidelines of Professional Conduct for Educational Interpreters.
- Maintains required confidentiality of personal information about students and staff.
- Maintains professional boundaries when communicating with consumers and coworkers.
- Demonstrates professionalism by participating in relevant trainings and working toward upgrading interpreting credentials.
