#### **MAJOR FUNCTION**

The Speech-Language Pathologist is responsible for conducting evaluations, providing educationally relevant treatment for students with speech, language, and related disorders across grade levels, in accordance with federal, state, and district policies. The Speech-Language Pathologist works independently within the established scope and practice for the profession.

## **ESSENTIAL RESPONSIBILITIES**

- Serves as a resource for school-based teams regarding speech, language, communication development and the impact on educational achievement.
- Provides speech, language, hearing, and communication screenings/evaluations for students referred through school-based teams in accordance with the established state/district eligibility criteria.
- Reports and interprets findings of evaluations to all stakeholders
- Develops educationally relevant recommendations, therapy, and Plans of Care in accordance with current eligibility and Individual Education Plan (IEP) Processes.
- Consults with IEP teams to develop and implement communication goals, services, accommodations, and classroom strategies for students with speech and/or language needs.
- Develops schedule for providing speech and/or language services.
- Provides services and direct instruction to students with speech-language and related disabilities using a variety of service delivery models.
- Monitors student progress and adjusts goals and objectives when indicated.
- Maintains documentation of student progress data and service records in accordance with district, state, and federal policies, including privacy and confidentiality requirements.
- Follows all district and Medicaid requirements for documentation of services and submission for Medicaid reimbursement.
- Collaborates with teachers and other school staff to meet student needs related to established communication goals and objectives.
- Participates in specialized professional learning activities designed to improve professional practice and as required to maintain licensure and certification.
- May, with district approval, provide clinical supervision of Clinical Fellows, Clinical Practicum Students, and Bachelor level Teachers of Speech Language Impaired.
