| <b>QUALIFICATIONS:</b><br>High School Diploma or possession of a GED, plus operating knowledge of trucks and related automotive equipment; or an equivalent combination of education, training and experience. Possession of a valid state of Florida class "B" commercial driver's license (CDL) to include "air brake" qualifications.  |
| <b>MAJOR FUNCTION</b>   |
| Performs semi-skilled work in the safe, efficient operation of light and heavy equipment including delivery trucks, forklifts, yard trucks and related equipment. Performs heavy manual labor routinely, and is responsible for maintaining simple shipping/receiving records. Work is performed independently, under general supervision.  |
| <b>ESSENTIAL RESPONSIBILITIES</b>   |
| <ul style="list-style-type: none"> <li>• Operates various light and heavy equipment, as assigned, applying knowledge of Florida State traffic and safety rules and regulations; maintains assigned vehicle.</li> <li>• Loads, delivers and unloads warehouse materials such as instructional, maintenance, food staples, government commodities, furniture, physical education, arts, industrial arts, band, large and small cafeteria equipment and custodial supplies, and confidential forms and tests; may pick up, handle and deliver chemicals, toxic substances and laboratory or exotic animals, as necessary; obtains verification of delivery.</li> <li>• Moves office or school furniture on delivery site; may unload railroad cars; delivers special equipment and relocates furnishings from one school site to another.</li> <li>• Maintains simple records on shipments received or delivered.</li> <li>• May assist in performing annual warehouse inventories, and other related activities.</li> <li>• Lifts heavy objects on a routine basis; may clean warehouse areas.</li> <li>• Performs semi-skilled tasks from oral or written instructions.</li> <li>• Performs other related duties as assigned.</li> </ul> |
