Dr. Evans reported on the following:

School Improvement Plan: A draft/summary of the 2011-12 School Improvement Plan was distributed and discussed. Dr. Evans reviewed the goals which included:

- Improvement in FCAT Reading and Writing scores.
- Improvement in EOC scores in Algebra and Biology.
- Increase teacher training.
- Increase tutoring.
- Improvement in attendance, suspensions and the dropout rate.

The draft of the School Improvement Plan was approved.

School Grade: Dr. Evans provided a summary of the new High School Grade components. Some of the new components are; graduation rate, acceleration and readiness. Dr. Evans reviewed our projected scores in these areas and predicted a “C” grade for this year.

Budget: Dr. Evans reviewed some of the budget resources available. They include Title 1, State funds and “Grants from athletes.”

Building upgrades: Dr. Evans shared that the roofing project is nearly completed. The WiFi project will be up and running within a week. There some scheduled grounds improvements and renovations to the Auditorium.
