Applications and supporting documentation must be postmarked on or before **June 1**, **2023**. We also require a copy of their official transcripts (high school and college, if applicable), postmarked on or before **June 20**, **2023**. Applicants are also strongly encouraged to include letters of recommendation. Incomplete applications will not be considered.

The student must reside North of Walsingham Road and South of Klosterman Road in Pinellas County. Graduates must attend a fully accredited College/University in the State of Florida and maintain "full-time" status. Awards are only for undergraduate work and are renewable at the discretion of the Awarding Committee for up to a total of four years.
