Response: Pinellas County has a Parent Advisory Council (PAC) composed of parent representatives from Title I schools and District Title I personnel. Each Title I school selects a parent and alternate to be a member of PAC. PAC provides input into the development, implementation and evaluation of the LEA Parent Involvement Plan (PIP), District Parent Survey, the Title I Part A application and use of Title I funds. PAC meets twice a year (September and May). Each Title I school is asked to select a parent to be a member of PAC.

At the September meeting PAC reviews the plans. Members are made aware of how to access the plans and how to obtain translation, if needed. Members are asked to disseminate information to their school's leadership team. Members are given information regarding the Title I program and application, as well as the purpose of PAC. The Title I Senior Coordinator for Evaluation presents the Title I Annual Parent Survey data. PAC also reviews the District Parent Survey data from the previous year, and provides suggestions and revisions for the administration of the parent survey.

The May meeting entails revising the plans and discussions of goals. Additionally, the data from the Title I Annual Parent Survey is presented and discussed. The information is utilized to drive the discussion and revisions for the LEA PIP.

Once the PIP is complete a copy is sent to FDOE. The input for the other plans is provided to the Title I Family Education Specialist.

The Title I funds reserved for Parent Involvement is allocated to Title I schools in Pinellas County, funds are set aside to support activities and materials for the Pinellas County School District's Title I Family Resource Center Library. Decisions regarding the use of the Title I funds set aside for Parental Involvement in the schools, will be made at the school level during the development of the School Improvement Plan and its budget. Parents of Title I students are involved in this process through the School Advisory Council (SAC) and other methods, such as surveys to gain parental input.

The Title I Family Education Specialist determines how the funds will be utilized at the Title I Family Resource Library based on parent library surveys, parents' and students' requests, and the need to replace materials.

*Technical Assistance will be provided to our Title I School Administrators at our staff meetings held in August, January and May. Each Title I Principal will receive a Title I Handbook with procedures and policies. Additionally, new Title I principals will receive an additional half day training, as well as periodic help sessions, as needed.

* District Title I staff will share Title I information and parent involvement best practices with the members of the Parent Advisory Council(PAC); they will share information with their various school leadership teams and parent groups.

*The Pinellas County School District Title I Family Resource Center Library provides parent and child (K - 8) resources for check out. The resources include leveled books, math/reading games, manipulatives, adult resource books and various pamphlets. The center is open Monday -Friday, with extended evening hours on Monday and Thursday. The Family Resource Center Library is open to all families from Title I schools.

*The Title I School PIPs will be available at the schools by the end of October. The Title I Family Education Specialist will visit each Title I school to review and monitor the School's Parent Involvement Plan. Additionally, the Title I Family Education Specialist will review the schools' Title I Parent Station, to ensure that the various Title I plans are readily available, Parents Right to Know, the Compact, the Title I Parent Empowerment Toolkit, and additional pertinent information for families. Also, review the school's Title I Electronic Audit Box.

*The Title I Family Educational Specialist will update information on the Title I Moodle site and share best practices during Title I Technical Assistance meetings. Additionally, provide a timeline of important dates to help schools effectively plan.

Response: The Pinellas County School District Title I will meet with the Parent Advisory Council (PAC), made up of parent representatives from Title I schools and District Title I personnel two times during each school year, September and May. During the September meeting the PAC will receive a copy of the LEA Title I PIP. The Family Education Specialist will lead a discussion on each section of the plan. Also, Title I School Administrators and PAC members will be asked to solicit information and input from parents, regarding the LEA PIP.

PAC will meet with the Title I Senior Coordinator for Evaluation to review and revise the Title I Annual Parent Survey, in order to gather information regarding the best day and best time of day for parent involvement activities, what areas do parents need to build their capacity, identify barriers that prevent parents from being involved at individual schools and countywide parent activities, and to determine if we are meeting the needs of our non-English speaking parents and disabled parents.

The Annual Title I Parent Survey will be available online at the District's website and Title I schools' websites, paper versions will be distributed to the schools for dissemination to the parents that request a paper survey. During the May meeting, the council will review and analyze the Annual Title I Parent Survey results. Additionally, members will review their schools' data in order to develop strategies and utilize best practices to promote increased and meaningful parent involvement, that will positively impact student achievement.

The Senior Coordinator for Evaluation and the Title I Family Education Specialist will also organize and conduct parent focus groups in order to gather parental involvement data, evaluate the effectiveness, as well as barriers of parental involvement and how to continuously build parent capacity to impact student achievement.
