# The Following Recommendations are on Track for 2012-13

## Vision and Mission and Self Assessment for Pinellas County Middle Schools

- VISION: 100% Student Success
- MISSION: Pinellas County Middle Schools will engage students in meaningful instruction by creating a safe and respectful learning environment to build community and sense of belonging for all students
- Research-Based resources for a school self assessment needs assessment available to all middle schools;
   Schools that Work, This We Believe, Pre-Career Academy Needs Assessment

# Pre-Career Academy Pilot Programs and Program Planning

- Clearwater and Lealman Intermediate Schools to open pilot Pre-Career Academies based on student interest surveys
- Grant to open an Information Technology Pre-Career Academy has been awarded to Pinellas Park Middle. A second grant has been submitted for Bay Point Middle
- Other middle schools will be supported in conducting needs assessment and student surveys to identify Pre-Career Academy programs to develop in subsequent years

### Task Force to Reduce Chronic Disruptions to the Learning Environment Recommendations

- Final recommendations to expand alternative site opportunities for disruptive middle school students will be shared later at this workshop.
- These "Pathways to Success" programs at two middle sites will be established to accommodate 60 middle school students (an increase of 36 seats from the current MS DELTA program).
- A revised process for referring students, including ESE students, is being developed with the Area Superintendents.

## Course Recovery Classes (Port of Entry) for Overage and Failing Students

- A full year class section for course recovery is being provided at all middle schools.
- A variety of options are available to schools to deliver this recovery or acceleration.
  - Moodle, NovaNet Bridges, Part Time, Pinellas Virtual
- Opportunities for students to make up course failures, to stay on grade level and to take grade level courses to accelerate a grade (i.e. 6.5 or 7.5 modified curriculum)

#### Social Studies Curriculum

 Highly engaging and participatory core curricular "History Alive" instructional materials have been selected for adoption in 6<sup>th</sup> and 8<sup>th</sup> grade for all middle schools

### Full AVID Implementation at all Traditional Middle Schools

- Provide expanded professional development in core content subjects with AVID district directors and consultants (Title II budget request pending)
- Promote pro-social school wide behaviors within the AVID school wide philosophy, options for Social Emotional Learning Benchmarks, Character and Civility/Respect Education programs and professional development (Title II budget)

#### Title I Funds for 6 Middle Schools

 Two high need (Intervene – Azalea and D-Pinellas Park) will be staffed to offer additional learning opportunities with 8 period schedule with staff teaching 6 courses

• 6 schools with Title I funds can implement several additional opportunities within the matrix through funding additional classroom teachers, behavior specialists, etc. (see Title I column).

#### Additional Recommendations

Board Input Needed

#### Title I Funds for 6 Middle Schools

• After a more recent review of the costs per school and the estimated Title I budget, it is recommended that two additional schools be provided supplemental Title I funds to implement the 6 of 8 schedule (Tyrone and John Hopkins).

### Additional Recommendations from Executive Reform Committee

- 1. Scheduling continues to be a significant barrier to implementing many of the middle school reform recommendations. Principals express a need for a 6 of 8 model. There is also a need for a scheduling software application that is compatible with teaming.
  - After a more recent review of the costs per school and the estimated Title I budget with the Area
     Superintendents, it is recommended that two additional schools be provided supplemental Title I funds to implement the 6 of 8 schedule (Tyrone and John Hopkins).

### Additional Recommendations from Executive Reform Committee

2. Fully implement a clearly defined staffing model to support middle school "house concept", with 3 assistant principals, 3 guidance counselors, 3 clerks and a front office clerk for all middle schools

### Additional recommendations from Executive Reform Committee (continued)

3. Support for developing the school-based "Success Academy" model with VE ESE teacher flexibility to support PS/RtI (Multi-Tiered Support System) for academic and behavioral interventions by restoring the lost unit from 2011-12

### Additional recommendations from Executive Reform Committee (continued)

4. The need to address teaching pro-social skills is paramount. The following quote was shared . . .

"We need to get out of the discipline business and into the curriculum business, or we are going out of busines"
