Your student is currently enrolled or has previously taken a business technology class in the BETA Academy at Gibbs High School. Business classes prepare your student for today's workplace through education of leadership skills, career exploration, development of character, fostering citizenship, building self-confidence, and assisting in occupational goals. Because developing these skills are an important part of our program, participating in different co-curricular activities like Future Business Leaders of America (FBLA) are a must. All students enrolled in a business class (previously at Gibbs or currently) are eligible to join FBLA, along with students enrolled at Gibbs High School, including PCCA, BETA, and traditional students. #### **Membership Information and Requirements**
