

• NOTE: Each school will schedule a maximum 15 regular season contests, to be funded by district office. Each team will schedule games against all North or South division opponents. An additional games will be scheduled against teams within the conference. The other games can be scheduled against private schools or out of county teams within 75 miles. For additional games teams can opt to play private, out-of-county, or even out-of-state teams in an FHSAA Classic, an invitational tournament, or a shootout. Any contests beyond those funded by Central Athletics will be the financial responsibility of the schools competing.

NOTE: All schedule changes must go through your administration who will contact the Director. No schedule change is final until approved by Director.

NOTE: Any school not represented at a PCAC All-Conference Meetings will be subject to a monetary fine. Fines assessed can be appealed to the Director in writing.

• NOTE: All schools must complete their schedule on this form and turn in a copy prior to leaving as well as return a copy to their APA. Schedules will become final once reviewed by the Director.

• NOTE: Twelve out of the 15 JV contests must be scheduled against PCAC teams. The three additional JV games can be against non – conference teams. JV teams can play in one tournament during the season. The tournament must be approved by Director of Athletics and the school's principal.

• NOTE: Games not included on the sheet of BOTH schools will NOT be added to the master schedule.
