## What is Title I and How Does It Work?

- Title I is the largest federal assistance program for our nation's schools
- The goal of Title I is a higher quality of education for <u>every</u> child. Its purpose is to address the academic needs of students and to assist them in meeting their state's academic standards
- The program serves millions of children in public elementary and secondary schools each year including eligible students in private schools
- The federal government provides funding to states each year for the Title I program
- The Florida Department of Education sends the money to our district, Pinellas County Schools
- The school district identifies eligible schools and distributes the Title I funds to the school
- The BCHS implements a school-wide program, all students benefit from the supplemental services provided by Title I. Every parent is a Title I parent.

## **BCHS Title I Budget**

- The BCHS is provided \$303,831.00 to pay for services and programs for our students. The Title I Parent Involvement budget is \$5,000.00
- We use our Title I funds to pay for the following:
  - Three full time student support positions (one counselor and two MTSS coaches)
  - Part of our instructional literacy coach position
  - Addition time for our part time Volunteer Coordinator
  - Supplemental instructional resources for core subject areas
- Parents can be involved with our Title I Budget decisions through our School Advisory Counsel (SAC)
