To: Parents or Guardians of all 6th Grade Students

Your child **will not be permitted** to enter or attend the 7th grade in August of 2018 without proof of the following immunizations or valid documented exemption:

- **One Tetanus-diphtheria-pertussis (Tdap) booster**
- **Two Varicella Zoster (chickenpox) vaccines or documented proof of the disease**

For the school year **2018-2019**, students entering or attending 7th grade are **REQUIRED** to have a **Tdap** (tetanus-diphtheria-pertussis) prior to attending class on the first day of school, or have a valid documented exemption. This grade level is also required to have two **varicella** vaccines.

Pinellas County Schools are required by Chapter 64D-3.046, Florida Administrative Code, to enforce these immunization requirements.

A completed Certificate of Immunization for (DH 680) is issued when the student has received all required immunizations. After your child has received these vaccines, please turn in this completed form to your child's school.

Be sure to get started now, so your child is ready for the first day in August 2018!

Please contact your child's healthcare provider. If your child does not have a healthcare provider, immunizations are available **at no cost** at all Department of Health – Pinellas sites listed below. No appointment is needed!

Atencion: Padres y Tutores de Estudiantes de Sexto Grado

A partir de Agosto 2018, su niño(a) **no sera permitido** a entrar al Septimo grado sin prueba de las siguientes vacunas:

- **Tetano-Difteria-Pertussis (Tdap) (1)**
- **Viruela Zoster (Varicela) vacunas o documentacion por enfermedades (2)**

Sera un requisito para estudiantes que comiencen el Septimo grado para el año escolar 2018-2019 tener **Tdap** (Tetano-Difteria-Pertussis) antes del primer dia de clase, sin Tetano-Difteria **no seran aceptados**. Tambien seran requerido dos vacunas de **varicela** para este grado.

El capitulo 64D-3.046 requiere que las escuelas del Condado de Pinellas, Codigo de Administracion, enforzen estos requisitos de vacunacion.

Luego de que niño(a) habra completado las vacunas requeridas, usted recibira un Certificado de inmunizacion (DH 680). Cuando el niño(a) haya recibido estas vacunas, favor de entregar esa forma a la escuela de su niño(a).

Asegurese de comenzar este proceso ahora, para que su niño(a) este listo para el primer dia de clases en Agosto 2018!

Favor contactar al proveedor de salud de su niño(a). Si su niño(a) no tiene proveedor de salud, las vacunas estaran disponibles **a no costo** en todos los Departamentos de Salud de Pinellas. No se requiere cita.
