**School's Mission Statement:** The mission of Perkins Elementary School is to provide a positive learning environment and quality educational experiences, thus enabling our students to reach their full potential academically, socially, creatively, and culturally, through the cooperative efforts of the family, school, and community.

Currently our greatest challenge is recruitment and retention of families who are 100% committed to our Magnet Program and family expectations. Also, while we have an arts-focused Booster Organization, we recognize the need to "reboot" our PTA to be better attended and more representative of our collective family stakeholders. Currently, it's very "staff-heavy" in terms of activity.

There are many ways in which we collect feedback and communication from our families. After each event is held, we send out survey links, we invite the community to join us in SAC, PME and PTA. We make sure to have our emails and doors always open to listen to family's ideas,

comments and/or concerns. We make sure that each event is tied back to how we can better support student learning and our Arts/International studies-based Magnet program at Perkins. This year we hope to continue to grow our SAC and continue to use parent feedback to improve the student and family experience at Perkins.

This year the goal of the school as a whole is to improve, increase, and update the way we communicate with our families. Between ConnectEd phone calls, emails, teacher communication, Facebook, website and marquee, we have found that our parents are craving more. We have continued a schoolwide monthly newsletter highlighting important events and upcoming dates, grade level specifics, overall school communications, specialists' tips, Title I news, PTA information and more. We hope that these types of additions to our communications will help to foster more authentic family engagement opportunities and build capacity within our school building and with the community.

Our school-based leadership team has been strategic in planning events and communication for our families this school year. As a 100% DAP Magnet Program, we have planned the calendar for the year and established events almost every month for the remainder of the school year. (i.e. conference nights, Literacy Night, Arts and Performance Nights, and various DAP-related recurring and showcase events). Our formal family engagement plan is embedded deeply into our Magnet program, with expectations for parent attendance and student participation in extracurricular events; a non-negotiable expectation of our school, as a stipulation of enrollment at Perkins.

Part of our staff professional development during preschool will focus on how and when to communicate with families, shifting staff communication to newsletters, emails, and Focus communications to proactively communicate with families, encouraging family involvement in academics and our magnet as well as fostering relationships of trust to get to know students and families better to support student success. This year's staff PD will include data training to support teachers with how to talk with families about student academic data and goals using clear language and tips for support at home. This will help families understand how to support student achievement with academics at home.

This year in addition to Open House, we will host a Meet-the-Teacher event to allow families and staff to begin building relationships and open communication before the school year starts. We also have multiple advocacy groups (PTA and Perkins Magnet Endowment) who support ongoing events and ways to support students and teachers in our core mission.

### How will you address barriers to increase attendance and academic support at home?

We will offer a variety of meetings throughout the year that encourage family participation and feedback. To accommodate different schedules, meetings will be held at multiple times—some before school, some shortly after dismissal, and others in the evening—to provide all families with flexible options to stay involved.

All families will be regularly and openly invited to participate in key decision-making groups, including our PTA, School Advisory Council, and Perkins Magnet Boosters. Invitations will be shared through multiple methods such as phone calls, emails, and text messages to ensure accessibility for all.

Each week, we will share timely and helpful information to support learning at home. This will include direct communication from teachers to their students' families and weekly updates from the principal to the entire school community. In addition, our monthly *Perkins Press* family engagement newsletter will offer reminders, resources, and highlights of school events and student achievements.

To encourage strong family turnout, schedules for school events and performances will be posted several weeks in advance, giving families time to plan and participate.

Through consistent, inclusive communication and flexible opportunities for engagement, Perkins Elementary will continue to strengthen the vital partnership between school and home.

We recognize that meaningful family engagement is essential to student success, and we must continue to grow and strengthen how we connect with families in authentic, accessible ways. Expanding our use of social media will allow us to share inspiring stories, student achievements, and unique experiences that define Perkins Elementary Center for the Arts & International Studies. By using these platforms to drive a positive, consistent narrative, we can celebrate our students' growth and the vibrant, arts-rich learning environment that makes our school special. Through our *Perkins Press* newsletter, emails, texts, and phone calls, we will also share information from family events, stakeholder meetings, etc. to keep families who were unable to attend events informed.
