I am an educator who holds an overall 2.5 college GPA and a three year temporary **STATE** certificate and who will meet the following criteria prior to program completion:

- A. Take and PASS three exams through www.fl.nesinc.com:
 - 1. General Knowledge Test (GK) (as required by the state)
 - 2. Florida Subject Area Exam (SAE) (as required by the state)
 - 3. Florida Professional Education Exam (PEd) (as required by the state)
- B. Successfully complete all district course work that includes required seat time and demonstration of each module task for certification (including PCS ESOL and reading courses).
- C. Attain confirmation of mastery of the Educator Accomplished Practices by the site administrator.
- D. Maintain an electronic portfolio of required documentation as evidence in demonstrating competency.
- E. Attend Embrace Pinellas or Survival Skills Training.

■ DISTRICT Certification - TTT Program

STATE Certification - TTT Program

I am an educator who holds a three year temporary **DISTRICT** certificate. The following criteria will apply with either option chosen.

- A. Take and PASS:
 - Each of the three sections of the TABE (Test of Adult Basic Education) Level A, at one grade level higher than the student exit level requirement established for the program being taught within one year of hire. Applicants with an Associate's degree or higher, who have received passing scores on the GK (General Knowledge) exam are exempt from the TABE requirement.
 - 2. The appropriate industry certification for the teaching assignment within one calendar year from hire date.
- B. Successfully complete all district course work that includes required seat time and demonstration of each module task for certification (including PCS ESOL and reading courses).
- C. Attain confirmation of mastery of the Educator Accomplished Practices by the site administrator.
- D. Maintain an electronic portfolio of required documentation as evidence in demonstrating competency.
- E. Attend Embrace Pinellas or Survival Skills Training.

Upon completion of all the above you will be eligible to apply for a Florida Professional Educator's Certificate **OR** a Pinellas County School District Educator's Certificate.
