

1. Training scheduled beyond contractual hours <u>may</u> qualify for trade credit.

2. Training used for the trade day incentive must:

- Support the District Strategic Plan.
- Align with the site School Improvement Plan (SIP).
- Occur between May 30, 2024, and May 30, 2025, per individual contractual workdays.
- Be conducted outside of the individual's contractual day, on evenings, or Saturdays.
- Be approved for trade by course facilitator **prior** to the training being offered.

3. No stipends, contracted services, or TDEs can be used in conjunction with a trade day.

- Trade cannot be interchanged with stipend after original issue.
- 4. All site-based training requires pre-approval by Content Supervisor/Component Author and is coordinated by the site ProEd Facilitator.

5. A personal day used for trade will not be reinstated.

6. Verification of training requires:

- Confirmation of attendance with the participant's signature on the sign-in sheet.
- A completed Trade Day Training Assessment Survey includes the signature of the training instructor/coordinator. (training must be completed between May 30, 2024, and May 30, 2025)

The official Trade Day Training Assessment Survey form contains the following statement: "I understand that no financial compensation will be provided for unused trade days. Trade time earned for training must be used only on the predetermined days identified on the Pinellas County Schools calendar as a 'trade day' option for that school year. Unused trade time, after the last designated trade day for that school year, will be forfeited."

7. Use of Trade Day Training Assessment Survey (training must be completed between May 30, 2024, and May 30, 2025)

- The Trade Day Training Assessment Survey is distributed to class participants when all class requirements are met. Class requirements will include completion of prerequisites and/or assignments, tasks, implementation, follow-up, etc., which may extend beyond class seat time.
- The Trade Day Training Assessment Survey is signed by the training facilitator/coordinator at the close of the training and the participant's administrator when submitted for approval for use of trade time.
- Trade Day Training Assessment Surveys will not be reissued.
- Completion of surveys at the close of training, submitting surveys prior to use for consideration of trade time on approved trade days, and retaining the yellow copy for one's personal records is the responsibility of the individual requesting trade time
- Trade documents are subject to audit, requiring accurate recordkeeping.
- A maximum of TWO days may be earned and traded between May 30, 2024, and May 30, 2025.

8. Online training – For ESOL and Reading Endorsement Courses Only

- A maximum of TWO days may be earned for approved ESOL or reading endorsement courses completed between May 30, 2024, and May 30, 2025.
 - > The training facilitator sends the log of hours to the participant when the online course is completed.
 - > The log of hours is completed in its entirety by the participant and submitted to the ESOL Office or Reading Department.
 - The ESOL office or Reading Department verifies completion of course, and verifies that the number of hours are outside the contracted day.
 - > The ESOL Office or Reading Department sends the Trade Day Form to the participant.

Note: Use of personal time and reporting of absences must be in compliance with School Board policy.

For training completed between May 30, 2024, and May 30, 2025, the participant will:

1. Complete the Trade Day Training Assessment Survey in its entirety. Assessment should be signed by the trainer once all class requirements are met.

2. Obtain the administrator's signature on the Trade Day Training Assessment Survey.

3. Submit Trade Day Training Assessment Survey (yellow copy) to the site-based individual responsible for payroll.

4. Keep a copy for personal records

Trade Day Training Assessment Surveys are not reissued.

• No tracking of trade time is maintained in the Professional Learning Network (PLN). PLN tracks recertification points/hours

Final authorization of trade validity is:

- Provided by the principal
- > Confirmed by the signatures of the presenter/trainer, participant, and administrator on the Trade Day Training Assessment Survey or Trade Verification form.

NOTE: Only Trade Day Training Assessment Surveys with presenter/trainer, participant, and administrator signatures will be honored for trade day credit and are due when requested prior to issuance of trade. Trade balances are not carried over from one school year to the next school year.
