What are the changes for 2019?



Aetna will be the new medical carrier beginning January 1st. If you did not login to the annual enrollment website, your medical coverage has defaulted to:

- National Networks for all three plans
- No Primary Care Physician (PCP) required
- > No referrals to specialists required

ID cards: You will receive one ID card or two ID cards per family if you and your spouse are enrolled in a plan. If you need additional cards, you can request cards from Aetna's Concierge Customer Service at 866-253-0599, access ID cards on the Aetna Mobile app, or print cards after you register with Aetna Member website.

- Your health insurance ID and Payflex cards will arrive in a plain white window envelope.
- CDHP+HRA members, will receive 2 separate cards-- a member ID card and a PayFlex Card®, debit card
- Unused CDHP PCA funds will roll over to Aetna Healthcare Reimbursement Account (HRA) in mid-March 2019
- If you changed plans from the CDHP to another plan, the PCA funds are forfeited

•	If you enrolled in an Aetna medical plan, you should verify your doctor is in the network. Notify your doctor's office that Aetna is your new insurance carrier. Be sure to bring your ID card for your first visit. You do not need a referral to see a specialist on any of the three plans.	 Examples of transition of care treatment include, but are not limited to, pregnancies beyond 20 weeks, cancer therapy, post-operative periods, dialysis, home health therapy, and durable medical equipment services. If you and/or a covered dependent are currently undergoing an active course of medical treatment, please contact Aetna Concierge at 866-253-0599 to discuss transition of care issues. 2018 Expenses: Don't Miss Humana's FSA Claims Submission Deadline!

If you're currently enrolled in a 2018 Healthcare or Dependent Care Flexible Spending Account (FSA), you must submit your claims to Humana for eligible expenses incurred and paid through December 31, 2018. Also, Humana *must* receive your completed claim forms no later than March 31, 2019. It is important not to wait until the last few days before the deadline, in the event that your claim form is not accurate or is missing information or receipts. Due to IRS rules, Humana cannot give you additional time after the deadline.

2018 FSA Card & Personal Care Allowance Card – Inactivated

Due to Humana changing platforms, your Humana CDHP Personal Care Allowance card (PCA) and/or your medical Flexible Spending Acct. will be frozen beginning December 25th. You will have to pay out of pocket for eligible medical expenses and request reimbursement through a manual claim form for any expenses incurred after December 24. 2019 Aetna new Flexible Spending Acct. Administrator

Effective Jan. 1, Aetna will administer the Healthcare and Dependent Care FSA. Enrolled employees will receive a new Payflex Card. Make sure you provide your physician's office and pharmacy with your new debit card.

Having the wrong personal information on file can delay correspondence from our insurance carriers, or cause problems with claims. If you have moved, changed your phone number, or recently married and changed your last name, you will need to update your personal HR record with Pinellas County Schools:
