#### Health Reimbursement Account (HRA) reminder

If you were enrolled in 2019 in the CDHP medical plan and had the HRA account provided by the district, the deadline to submit 2019 claims to PayFlex for reimbursement or substantiation is March 31, 2020. These funds may be used for eligible medical or prescription services.
