#### PCS Special Pay and FICA Alternative Plan through BENCOR

# *New Investment Provider, Higher Interest Rates for Guaranteed Interest Account and Updated Mutual Fund Options*

Pinellas County Schools offers a "Special Pay Plan" for employees retiring, entering DROP, or separating from service. This plan provides a tax savings opportunity for accumulated sick and vacation payout. In addition, the district has a" FICA Alternative" retirement plan for our temporary employees and substitutes. BENCOR administers the district's Special Pay and FICA Alternative plans.

Recently, BENCOR, through a formal proposal process, recommended a transition for participants in the Prudential Guaranteed Long Term Fund to move to Lincoln Financials' Stable Value Fund. This transition, scheduled for June 2, 2020, will give participants a higher interest rate on their money (2.05%) as well as a higher minimum interest rate guaranteed for the duration of the contract (2.05% through 6/30/2025). Additionally, because of the timing of the transition, this move is expected to generate a positive Market Value Adjustment to participants in these investment funds. Finally, as part of the proposal process, BENCOR recommended an update to some of the mutual funds offered through these plans. Those updates will become effective in early July. More communication on those improvements will available in the upcoming weeks.

We are excited to share this good news! The enhancement to each participants' account will be reflected on their next statement.
