Your 2026 Annual Enrollment Starts Monday!

Mark your calendars: The Annual Enrollment window for 2026 benefits will be open from **October 15 through November 3, 2025**.

During this period, employees may enroll in, make changes to, or cancel their benefit elections for the upcoming year. This year's enrollment window is longer than in previous years, giving you more time to explore your options and make the best decisions for your needs.

! Important Note: This will be your only opportunity to make changes for 2026 unless you experience a qualified family status change. If you have moved recently, please verify your address to make sure it has been updated. It is important to have your correct address on file for you to receive Annual Enrollment information and benefit plan ID cards, if applicable. PCS employees may update their address through the [PCS Employee Self Service](#) (ESS) website.
