Enrollment Information

2025 Annual Enrollment Ended – Confirmations Emailed

On Wednesday, November 6th, an Annual Enrollment Confirmation for 2025 was emailed to all benefit-eligible employees.

It is very important that you take a moment and review the confirmation to be sure your elections and dependent coverages are correct.

If you notice any discrepancies, please contact the Benefits Team at 727-588-6197 no later than Friday, <u>November 8th</u>.

Life Insurance Elections for New or Increased

Coverage

If you enrolled in Life Insurance for new or increased coverage during Annual Enrollment, remember that the amount elected will be subject to Evidence of Insurability (EOI).

Important Action: Evidence of Insurability Application

- Application Sent: The Standard will send a link to your PCS work email to complete your Evidence of Insurability application on Monday, November 11.
- **Completion Timeframe**: You have **30 days** to submit the application.
- **Approval**: Your coverage will not be active until The Standard has approved your application.
- **Coverage Status**: If you do not complete the application, you will not be approved for the coverage you requested. However, any existing coverage you have will remain unchanged.

Reminder: Life and AD&D Insurance will be reduced once an employee reaches age 70. It reduces more at age 75 and 80. Your spouse's Life and AD&D Insurance coverage will terminate at age 70. Please refer to the <u>2025 Employment Benefits & Wellness Guide</u> for more detailed information.





Dependent Documentation Reminder!

If new dependents were added to your medical, dental, or vision coverages, you must submit documentation to Risk Management. Email the documentation to the Benefits Department at <u>risk-benefits@pcsb.org</u> by November 15, 2024.

For your legal spouse, please submit a copy of your marriage license. If you do not have a copy of your marriage license, we will accept a copy of page 1 of the most recent tax return. (You can black out financial amounts).

For children, please submit a copy of their birth certificates, adoption certificates, and/or permanent legal guardianship certificates. To view more information of Dependent Eligibility and documentation, please see pages 18-19 in the <u>2025 Employment Benefits & Wellness</u> <u>Guide</u>. Failure to provide timely documentation will result in your dependents not being covered for the new plan year.

Dependent Audit Information

Receive Your 1095-C Early and Electronically!

Now's your time to sign up to receive your 1095C electronically.

Those completing this form electronically for **the first time and sign up by December 18**th will have their name entered into a drawing to win a Wellness Gift Basket!

If you are not currently enrolled to receive your 1095-C Form electronically, log into your <u>Employee Self-Service</u> portal during annual enrollment, and receive to 1095-C form electronically!

What exactly is a 1095-C Form?

A 1095-C form is your proof of insurance for the IRS.

Pinellas County Schools is required to send the1095-C to all employees offered medical insurance in 2024. While this form may assist in preparing a return, it is not required to file a return.

If you consent to receive this form electronically, you will be able to view and print this form on the 1095-C section in your Employee Self-Service portal.

Employees who do not consent to receive this form electronically, will receive a printed form and it will be delivered to their work location by January 31st.

Where do I find my 1095-C Form in the Employee Self-Service Portal?

If you consent to receive your 1095-C Form electronically, follow the instructions below:

1. Login into your Employee Self-Service Portal!





- 2. Once you have logged into the homepage of your employee portal, select the "1095C" link that is in the yellow box on the left side.
- 3. It will then ask you to select a "1095C Delivery Option."
- 4. Select "Review and Print My Own 1095-C Form" only if you would like to complete this form electronically.
