- **a.** Continue school wide positive behavior plan (Paws Theme); implemented Paws Assemblies to honor and celebrate student achievement and positive choices. <u>Plan</u>: Paws earned by students are displayed in hallways each month to give positive feedback school wide. School wide assemblies are held after each infraction period to celebrate our total paw count and recognize students who shine in specific areas. A new paw goal is set for students to achieve.
- **b.** Meet after each Infraction period with teachers to analyze infraction data. <u>Plan:</u> The SBLT and CST teams will review warning and detention data. Infractions will be recorded by teacher and grade level to assist in analyzing trends and areas of concern (homework, behavior, etc.). This data and analysis will be shared collected by our DMT and shared with staff throughout the year. SAC is also informed of this data to gain input and increase parent communication.
- **c.** On-going training and communication with all stakeholders: staff, parents and students. <u>Plan:</u> Initial PTA meeting GFS will be displayed and shared. Students and staff will be reminded of our GFS each morning on the announcements. Teachers will be provided with current information to support positive behaviors in their classrooms.

Also, review of guidelines and expectations will be ongoing via the daily morning announcements and through classroom teacher implementation throughout the school year. Teacher and school staff language will implement the GFS on a daily basis.

7. Attach or insert the planned and/or established Reward/Recognition System: Students may earn a Paw Print (die cut) whenever they are noticed making a good choice, saying something respectful and doing an act of kindness. Paws may be given out whenever and wherever by any TSFES staff member. Paws are posted in the hallways for students to see and also for cumulative growth to be recognized. On-going incentives can be given for accumulation of high number of school-wide paws earned. An end of the year "Paw for All" awarded as school wide recognition. Implemented Paws Assemblies after each infraction period to recognize high achievement in all subject areas as well as good character.

8. Attach or insert the plan to align classroom management systems with the school-wide behavior plan. All teachers utilize the GFS to guide their classroom expectations as well. Both are integrated in positive ways in all classrooms. These GFS are also tied into our Fundamental policies.

When a student misbehaves, the teacher will provide first a verbal reminder of a positive choice and will conference with the student. If the misbehavior occurs a second time the teacher will make parent contact often through a note in the child's planner. A third time of misbehavior the student will receive a warning, while restating the positive expectation. A referral to the counselor may also be initiated.

10. Our DMT gathers the infraction data to summarize. The SBLT will meet monthly and discuss the school wide plan (after an infraction period). The number of paws distributed, the number of warnings given, and the number of detentions will be examined. Also, behavioral data will be analyzed and the team will input this data in a PIC report via the PBES website. The team will define what areas of our school wide plan are working and which part may need more attention. This information will then be shared with staff during a staff meeting. Students will be notified of their positive progress after each infraction period and parents will be notified through our monthly newsletters. Staff will be offered the opportunity to provide feedback and offer suggestions as to any changes that may be beneficial due to our data.

- Oct. 2013: 1st infraction period data summarized/analyzed and shared with staff. Specific student concerns addressed through behavioral interventions and/or IAC if needed. 1st Paws assembly conducted!
- Nov. 2013: 2nd infraction period data summarized/analyzed and shared with staff. Paws assembly!
- Jan. 2014: 3rd infraction period data summarized/analyzed and shared with staff. Paws assembly!
- March 2014: School wide plan tweaked where needed to address specific areas of concern. Infraction
 period data summarized/analyzed and shared with staff. Monthly paw assemblies will continue.
 Enhance sharing infraction data with parents through school newseltters.
- May 2014: 4th infraction period data summarized/analyzed and shared with staff. Paws assembly!
- June 2014: Successful data of more paws distributed than warnings and detentions combined. Student success celebrated! School wide drumming event to celebrate over 1,000 paws earned this year!
 Maintain 0% suspension rate. Attain feedback from staff/PDSA school-wide plan to enhance plan for next year.
