DE students must...

- Meet all of the qualifications for the institution hosting the courses.
- Take at least 4 classes at their high school.
- Have a full schedule (7 active classes per semester).
- Have no more than 6 college level classes (DE, AP, AICE, IB) per semester.
- Be pursuing a 24-credit standard diploma.

EC/EA students must...

- Must complete World History, Biology, Geometry, Personal Finance, and HOPE prior to starting EC/EA.
 - + EC HOPE & Personal Finance deadline is June 30
 - + EA HOPE & Personal Finance deadline is June 15
- All state assessment graduation requirements must be met to apply to EA.

Initial Eligibility Requirements: (As determined by the Florida Department of Education)

- 1. Submit the Florida Financial Aid Application (FFAA) no later than August 31 after high school graduation.
- 2. Graduate from a Florida high school with a standard high school diploma or its equivalent.
- 3. Complete the 16 college-preparatory courses required for admission to a state university.
- 4. Achieve the required weighted GPA in the 16 college-preparatory courses per the chart below.
- 5. Achieve the required composite ACT® score, Overall Score on the Classic Learning Test (CLT®), or combined SAT® score. Tests must be taken no later than August 31 of the student's graduation year (or through January 31 for mid-year graduates), per the chart below.
- Complete the required number of volunteer service hours, paid work hours, or 100 total combined hours per the chart below.

Florida Bright Futures Scholarship Program Florida Gold Seal Vocational Scholars (GSV) 2025-26

Initial Eligibility Requirements: (As determined by the Florida Department of Education.)

- 1. Submit the Florida Financial Aid Application (FFAA) no later than August 31 after high school graduation.
- 2. Graduate with a standard Florida high school diploma or its equivalent.
- 3. Achieve the required weighted 3.0 GPA in the non-elective high school courses.
- 4. Completes at least three (3) full Career and Technical Education credits
- 5. Achieve the required minimum 3.5 unweighted GPA in Career and Technical Education credits.
- 6. Complete at least 30 volunteer service hours, 100 paid work hours, or a combination that equals a minimum of 100 total hours. For students entering grade 9 in the 2024-2025 school year and thereafter, 75 hours of volunteer service must be completed.
- 7. Achieve the required minimum scores on one of the college entrance exams per the chart below no later than August 31 of the year the student graduates from high school.

- 1. Students must earn the number of credit hours based on the student's enrollment type per term.
- 2. Students must maintain a minimum cumulative 2.75 GPA (unrounded and unweighted).

Florida Bright Futures Scholarship Program Florida Gold Seal CAPE Scholars (GSC) 2025-26

Initial Eligibility Requirements: (As determined by the Florida Department of Education.)

- 1. Submit the Florida Financial Aid Application (FFAA) no later than August 31 after high school graduation.
- 2. Graduate with a standard high school diploma or its equivalent.
- 3. Earn a minimum of five (5) postsecondary credit hours through CAPE industry certifications that articulate for college credit.
- 4. Complete at least 30 volunteer service hours, 100 paid work hours, or a combination that equals a minimum of 100 total hours. For students entering grade 9 in the 2024-2025 school year and thereafter, 75 hours of volunteer service must be completed.

Scholarship Restrictions:

Until a student has earned an eligible associate degree, Gold Seal CAPE (GSC) scholarships may only be used at postsecondary institutions that offer an applied technology diploma, technical degree education program (associate in applied science or associate in science), or a career certificate program.

Upon completion of an eligible associate degree program, a GSC Scholar may also receive an award for a maximum of 60 credit hours toward an eligible baccalaureate degree.

Renewal Requirements: (As determined by grade and hours submitted by your postsecondary institution.)

- 1. Students must earn the number of credit hours based on the student's enrollment type per term.
- 2. Students must maintain a minimum cumulative 2.75 GPA (unrounded and unweighted).
