MAJOR FUNCTION:

Provides professional development, support, and assistance to teachers with the infusion of technology in all curriculum areas.

DUTIES AND RESPONSIBILITIES:

- Surveys staff periodically to determine need for materials, equipment and training.
- Facilitates training in technology for teachers, students, parents, and the community.
- Collaborates with assistant principal to provide training in all curriculum areas.
- Collaborates with media specialist to provide training in and assist with multi-media presentations.
- Makes recommendations for purchases of equipment, software, and other appropriate instructional materials.
- Models teaching techniques and strategies in the classroom.
- Assists in classroom organization and management for effective use of technology in an integrated curriculum.
- Assists teachers in the development of interdisciplinary units and other integration strategies.
- Facilitates the training for beginning and new to the school teachers on the available technology and its use in the instructional program.
- Serves as a member of the school's technology committee and assists with the development of the school technology plan.
- Assists in the presentation and evaluation of emerging technologies.
- Provides in-house repairs of existing technology where possible.
- Manages local area network.
- Participates in district level professional development.
- Attends conferences, workshops, and vendor presentations to keep abreast of current and emerging technologies and effective techniques for infusing these technologies into the curriculum.
- Serves as a public relations contact for the school.
- Serves as a member of technology-related school improvement teams.
- Performs other related duties as assigned.

Bachelor's degree. Three (3) years of successful teaching experience. Knowledge of school curriculum. Evidence of training in technology and/or demonstrated use of extensive technology in the curriculum. Demonstrated leadership skills.
