# **GROUNDSKEEPER II**

#### **MAJOR FUNCTION:**

Performs responsible, semi-skilled manual work in overall outside grounds maintenance and upkeep at the Central Administration Building, a high school, a PTEC, or as an itinerant lead position or independent large mowing equipment operator. Work is performed independently and is reviewed through conferences and results obtained.

### **DUTIES AND RESPONSIBILITIES:**

- Operates push mowers, rider mowers, tractors, and similar equipment in the cutting of lawns, fields, play areas, embankments, gullies; utilizes bat wing and slope mower with radar arm in mowing large fields and ditches.
- Itinerants are responsible for transporting equipment from site to site and for providing training and lead direction to assisting personnel.
- Trims and cuts shrubbery, bushes, hedges, trees, using hand and power equipment such as hedge trimmers, chain saws, pole saws.
- Removes weeds by hand, with power weed-eater, or through chemical application; identifies pests such as fire ants and refers to appropriate personnel; edges, rakes, sweeps, cleans out ditches, and retention ponds, lays sod and moves dirt; sprinkles and fertilizes as needed.
- School-based positions are responsible for policing outside areas and picking up trash and other debris from lawns, driveways, walkways.
- Maintains flower beds including planting, weeding, fertilizing, and watering.
- Site-based positions may be required to apply knowledge of vegetation sustenance in the transplanting of shrubs, bushes, flowers, plants and trees.
- Transports fuel as the need arises; may be required to pick up and deliver furniture or other items when not involved in groundskeeping tasks.
- High school positions mark athletic fields for sports events and coordinate work schedules with coaches and school administrative personnel.
- May be responsible for clearing undeveloped land for future construction.
- Performs minor repair and maintenance of groundskeeping equipment.
- Site-based positions are responsible for the repair and replacement of sprinkler heads and the minor repair of sprinkler system pipelines.
- Plans work schedules, keeps records, maintains inventories, writes reports.
- May be responsible for the overall maintenance of stadiums and associated locker rooms including cleaning tasks and bleacher repair and painting.
- Applies knowledge of hazards and safety precautions in the performance of job duties.
- When not performing groundskeeping duties, may be required to perform inside custodial tasks or assist with semi-skilled building maintenance including pressure washing walls, loading/unloading trucks, moving furniture.
- Work may involve the lifting of heavy objects on a regular basis and occasional climbing.
- Performs related work as required.

#### **GROUNDSKEEPER II**

#### **MINIMUM QUALIFICATIONS:**

Two (2) years groundskeeping experience in a school system setting to include experience in operating large tractors and other grounds maintenance equipment. Possession of a valid State of Florida Class E noncommercial driver's license or a valid State of Florida Class A commercial driver's license (CDL) to include "air brake" qualifications.\*

\*Licensing requirements are based on assignment.

#### **PREFERRED**:

Successful completion of basic courses in Horticulture and Small Engine Repair.

Site-based Groundskeepers:

Successful completion of basic courses in Horticulture and Small Engine Repair plus successful completion of PCSB course in Irrigation Systems.
