INSTRUMENT TECHNICIAN-JOURNEYMAN

MAJOR FUNCTION:

Under general supervision, inspects and tests equipment or parts and instruments for repair, modification or overhaul. Tests, repairs and operates mechanical, optical, hydraulic, pneumatic instruments and computer-controlled equipment.

DUTIES AND RESPONSIBILITIES:

- Inspects, tests, adjusts and repairs instruments, using hand tools and precision testing equipment.
- Analyzes blueprints, sketches, control and wiring diagrams, and follows oral instructions to determine parts, tools, test equipment and sequence of operations required to perform duties.
- Analyzes and makes corrective adjustments to direct digital energy management and HVAC computer-controlled equipment, software, hardware.
- Analyzes energy management control equipment and makes corrective adjustments to equipment. Also recommends corrections to HVAC chillers, chilled water distribution systems, direct expansion systems, HVAC air handlers, variable air volume boxes and associated dampers and ductwork.
- Orders and organizes needed material; substitutes similar parts and devices if necessary.
- Interfaces with outside contractors to correct customer's problems and warranty concerns.
- Responsible for preparation and follow through on work orders, test results, reports and records.
- Applies strong working knowledge of personal computer hardware and software including file management, programming, energy management and direct digital control software, in performance of job duties.
- Performs other work-related duties as requested.

MINIMUM QUALIFICATIONS:

Graduation from high school or possession of a GED, plus four (4) years progressively responsible work experience in electronic controls. The successful completion of up to two (2) years of verifiable formal training in the trade (vocational, military, or indentured apprentice school) may be substituted for a like amount of the experience requirement. Possession of a valid State of Florida Class E noncommercial driver's license, and any other license as may be required by law.
