PAINTER - JOURNEYMAN

MAJOR FUNCTION:

Performs skilled journeyman level painting work of exterior and interior surfaces of buildings or other structures, surfaces and equipment. Work is performed independently under general direction and reviewed upon completion for conformity to established specifications and accepted standards and procedures of the painting trade.

DUTIES AND RESPONSIBILITIES:

- Prepares and cleans surfaces using sandpaper, burners, scrapers, sanding machines, dusters, and paint removers.
- Mixes and matches paints, varnishes, enamels, lacquers and paint and varnish removers to the specific needs of each project.
- Applies primers and finished coats of paint to the exterior and interior of buildings, furniture, mechanical equipment, and other structures by means of brush, roller, or spray equipment.
- Patches and does general repair of plaster and cement work; caulks and glazes.
- Leads, trains and assigns work to helpers.
- Lifts heavy objects and works at high levels of elevation on a routine basis; rigs and erects scaffolding; hauls and sets up ladders.
- Cleans and maintains tools and equipment of the painting trade, such as brushes and spray guns.
- Estimates time, cost, labor and materials needed.
- Performs other related duties as required.

MINIMUM QUALIFICATIONS:

Graduation from high school or possession of a GED, plus four (4) years progressively responsible work experience as a painter. The successful completion of up to two (2) years of verifiable formal training in the trade (vocational, military, or indentured apprentice school) may be substituted for a like amount of the experience requirement. Possession of a valid State of Florida Class E noncommercial driver's license, and any other license as may be required by law.
