PAINTER - LEAD

MAJOR FUNCTION:

Provides onsite supervision and participates in tasks. Is responsible for the completion of all assigned work in the absence of the service foreman. Performs skilled master level painting work of exterior and interior surfaces of buildings or other structures, surfaces and equipment and performs skilled technical work in the preparation and coordination of the maintenance painting tasks. Work is performed independently under general direction and reviewed upon completion for conformity to established specifications and accepted standards and procedures of the painting trade. Responsible for the use of proper methods and materials.

DUTIES AND RESPONSIBILITIES:

- Supervises employees and use of equipment in painting activities
- Assigns work on a daily basis; revises work schedules based on situations
- Trains employees in safety and technical aspects of job; ensures proper servicing of equipment
- Coordinates material deliveries and manpower for assigned painting tasks
- Ensures work is performed per specifications and provides input regarding product and vendor performance
- Assists in the evaluation of personnel
- Acts as the primary point of contact for communicating with customers and school staff in the absence of the service foreman
- Prepares and cleans surfaces using sandpaper, burners, scrapers, sanding machines, dusters, and paint removers
- Mixes and matches paints, varnishes, enamels, lacquers and paint and varnish removers to the specific needs of each project
- Applies primers and finished coats of paint to the exterior and interior of buildings, furniture, mechanical equipment, and other structures by means of brush, roller, or spray equipment
- Patches and does general repair of plaster and cement work; caulks and glazes
- Leads, trains, and assigns work
- Lifts heavy objects and works at high levels of elevation on a routine basis; rigs and erects scaffolding; hauls and sets up ladders
- Cleans and maintains tools and equipment of the painting trade, such as brushes and spray guns
- Estimates time, labor and materials needed to complete assigned task
- Performs other related duties as required

MINIMUM QUALIFICATIONS:

Graduation from high school or possession of a GED, plus four (4) years progressively responsible work experience as a painter plus experience acting in a lead or supervisory capacity, performing most of the duties stated above. The successful completion of up to two (2) years of verifiable formal training in the trade (vocational, military, or indentured apprentice school) may be substituted for a like amount of the experience requirement. Possession of a valid State of Florida Class E noncommercial driver's license and any other license as may be required by law.
