PROGRAMMER ANALYST

MAJOR FUNCTION:

Performs advanced, technical, analytical and design work in the development, implementation, and maintenance of moderately complex programs and systems. Work involves occasional limited project leader duties for overall application systems design on small projects, and advancing knowledge and skills by developing increasingly complex programs. Requires use of independent judgment; performed under general directions and reviewed through observation, conferences and effectiveness of systems designed.

DUTIES AND RESPONSIBILITIES:

- Performs all Programmer functions.
- Confers with user departments to research methods and procedures of operation to ascertain needs, and determine necessary modifications to existing programs and systems, or to require development of new systems; defines program decisions; designs report format; presents forms and data for approval and suggestions to project leader and/or users.
- Conceptualizes entire system structure, resource availability, and program requirements; controls and monitors systems activity both in development and maintenance for specific projects or systems.
- Assists in periodic examination and evaluation of programs; documents systems programs; develops test programs or run problem solving programs.
- Researches and resolves problems reported by users and computer operations personnel on application systems; works with other Data Processing Department sections to resolve problems or implement system changes.
- Communications with project leader on concerns, problems, and status of application programs and systems in process.
- Analyzes and corrects existing application programs to improve function, including reduction of operating time, and refinements to operating methods, techniques, and procedures.
- May provide technical assistance to lower level programmers.
- Performs related duties, as required.

MINIMUM QUALIFICATIONS:

Graduation from an accredited college with a Bachelor's degree in Computer Science or a related field, plus three (3) years progressively responsible business systems programming and analysis experience; or an equivalent combination of education, training, and related Pinellas County School Board experience.
