# VEHICLE MAINTENANCE COORDINATOR

#### **MAJOR FUNCTION:**

Performs highly responsible lead supervisory work carrying out corrective and preventive maintenance, scheduling and vehicle repairs. Works directly with Foreman at various repair facilities to accomplish vehicle repairs in the most productive cost effective manner. Work is performed independently under general direction.

#### **DUTIES AND RESPONSIBILITIES:**

- Coordinates, plans and schedules major and technical vehicle repair work; maintains related records and prepares reports as necessary
- Monitors warranty repair assignments, parts availability and repair facilities to achieve the most effective and timely production
- Maintains daily log on location and status of each vehicle undergoing maintenance or repair
- Investigates complaints of service or repairs to determine and resolve the problem
- Makes recommendations for service facilities, tool requirements and manpower scheduling
- Recommends service training requirements involved with improved productivity
- Maintains up-to-date service information at all facilities relative to repairs performed, equipment maintenance and state inspection/service requirements
- Applies working knowledge of both diesel and gasoline engine repair/overhaul, driveline components and methods involving proper vehicle maintenance
- Evaluates repairs needed for a group of vehicles concurrently to achieve the most productive scheduling
- May be required to fill in for the immediate supervisor in his/her absence
- Performs related work as required

### MINIMUM QUALIFICATIONS:

Graduation from high school or possession of a GED and four (4) years experience in the working operations of a vehicle maintenance department, two (2) of which must be in a supervisory capacity. Must Possess and maintain a valid State of Florida Class B commercial driver's license (CDL) to include "air brake" and "passenger" qualifications. Must possess and maintain Department of Education (DOE) school bus inspector certification.
