School's Mission Statement: All members of the TMFMS community are committed to providing a safe and a challenging learning environment that promotes college and career readiness by focusing on critical thinking, communication, collaboration, creativity, competition, and concern for others.

Measurable Outcomes: TMFMS will focus on building positive relationships with parents, families, and other community stakeholders to fulfill the school's mission, support the needs of students, and keep parents informed of their child's progress.

TMFMS will increase parental involvement at events and meetings, that focus on student achievement, by 10% in 2025-2026. Thurgood Marshall tracked 1,173 family check ins for Academic focused meetings in 24-25. We strive to improve by 10% and will increase the total for attendance to 1,290.

Thurgood Marshall Fundamental requires parent involvement as agreed upon by the Fundamental Contract. Parents are to attend 8 meetings per year. TMFMS always projects attendance based on the event type. On average, 285 families (this could be 1 member or multiple) participated each month in one or more of our meeting/event opportunities during the 2024-2025 school year. We will continue to track with QR code check-ins and Microsoft Forms to determine attendance for all family events and meetings.

SAC/PTA will be on the 2nd and 4th Monday of every month. SAC is conducted virtually on TEAMS and is open to all families for problem solving workshops with Learning Lab and Climate and Culture Grants helping to focus on SIP needs/goals. PTA is in person monthly and focuses on student life, parental involvement, and academic support at home. Back-to-School Night will engage families in meeting with teachers, identifying instructional goals, and continuing to build relational capacity with all stakeholders. We will also have a variety of academic showcases like National History Day Fair, Future Cities, Algebra Bowl, Great American Teach In, and more to increase parent opportunities to volunteer and work directly with teachers and the school community to support all types of academic growth for all students.

- School leaders will identify teacher leaders to help conduct family engagement events that focus on their content related expertise.
 - Avid strategy nights, core content strategy rotations, testing data chats and strategies, "Jaguar Journey Closing the Achievement Gap" Series, Learning Lab, and Data Review sessions to engage families in progress monitoring for Math and Reading.
- School counselors will facilitate teacher conferences with staff to help facilitate appropriate conversation.
- PD for staff will include role playing difficult conversations over the phone, coaching on how to address academic concerns, and provide resources for teachers to refer back to for future use.
- Leadership will actively monitor Focus Call logs to ensure teachers are connecting with scholar's families about academic goals.

Using the data, we can then tier teacher support with reaching out to families about the academic progress of the scholar.

• TMFMS will use QR codes for parent sign in as well as for end of meeting surveys. The results of our surveys will be reviewed with Admin, SBLT, and Department Chairs to ensure we are adapting to the needs and wants of all stakeholders.

How will you address barriers to increase attendance and academic support at home?

• Bi-weekly meetings with CST and MTSS teams will address attendance and academic support at home. We will also address the parent survey results to compare with those students and families needing further support. Learning Lab Meetings, and "The Jaguar Journey" Sessions will increase the availability to engage families through virtual sessions focusing on school-wide problem solving, students academic data, behavioral data, and achievement gaps for Reading and Math. Each meeting will provide guidance for at home support in an effort to continue to increase student achievement and learning gains for all.

How will you get the information home to parents using various modalities who do not attend?

• TMFMS will upload all parent communication, meeting presentations, and documents on our website. We will also provided flexible time options for a variety of meetings/events as well as virtual options for Title 1, SAC, and Learning Lab. All meeting dates and times will be published in July so that families can plan their year in advance and identify when they will be available to attend and participate.

- Weekly parent updates and a published school calendar of events and meeting will outline the dates and times for TITLE 1 Family Engagement meetings as well as all other school wide events. (Calendar will be published in July of 2025 for the entire school year)
- These meetings will engage parents in a variety of ways so they can apply their learning in an effort to support the students at home. Data will be reviewed for academic progress, academic interventions and needs, Positive Behavior Supports, as well as structures and processes that assist with student behavior in the school setting.
- SAC/Learning Lab meetings are provided monthly and the agenda will always include SIP and Title 1 updates.
- All stakeholders are invited to attend our Learning Lab problem solving workshops open to all stakeholders so that feedback and decisions
 are made with all in mind. Learning Lab will create a safe opportunity for all stakeholders to engage in the difficult discussions and
 problem solving opportunities that focus on equity, discipline data disparities, SIP and learning gains, as provide a sounding board for
 families to share concerns as well as provide recommendations for improvement.
- If a parent or family member requests more one on one support to focus on their specific scholar, meetings will be scheduled through student services and will be conducted in the mornings on a set day of the week.

• Surveys at the end of each Title 1 Family Engagement meeting will be provided to all families to obtain feedback. We will also add links to a survey for families wanting to provide virtual suggestions if they were unable to attend.

Flexible Parent Meeting

The majority of monthly events and meetings will take place in the evenings, with flexible times, variety of location options, and in-person and virtual environments. All meetings and events are scheduled in advance through the year at a glance calendar that is published in July. Weekly communication to families sends reminders with meeting/event options each Sunday at 5:30pm. This is also posted on our website, sent via email, and sent as a phone message.

Monthly morning meetings will be conducted through "All Pro-Dads" on the first Tuesday of each month. 2 academic focus meetings will be conducted in the mornings as well to focus on academic progress and testing after PM2 testing has been conducted for Math and Reading. These sessions will be conducted by our current staff members that are contracted service employees for Family Engagement only. SAC/Learning Lab/PTA will be on the 2nd and 4th Monday of every month. Concerts, performances, showcases, Back-to-School night, and athletics are conducted during a variety of times and at a variety of locations.

When parents are not able to attend the meetings, we post meeting minutes or virtual recordings on the school's website.

We also provide a variety of meeting opportunities and event types every month for families to satisfy their requirements of the fundamental contract.
