

Florida Civility and Sportsmanship Rules in School Athletics

3. Parents and spectators

- **Positive Support:** Cheer for their team and not against the opponent.
- Allow Coaches to Coach: Avoid criticizing coaches' decisions during games and practices.
- **Respect Officials:** Respect the officials and their authority during games.
- "24 Hour Rule": If there's an issue to discuss with a coach, wait 24 hours after a game or practice to schedule an appointment.
- Good Sportsmanship Expected: Repetitive and/or egregious unsportsmanlike behavior can result in spectator removal and potential trespass warnings.

Unsportsmanlike conduct and consequences

- **Definition:** Acts of a malicious and hateful nature towards officials, opponents, or attendees, including profanity, threats, slurs, or excessive physical contact, are considered unsportsmanlike conduct.
- **Penalties for Students:** Can include suspension or termination of athletic participation privileges. Gross unsportsmanlike conduct can lead to ineligibility for up to six weeks, with fines imposed on the school for repeat offenses.

• **Penalties for Coaches:** Can be suspended from coaching or attending the next game, with the school facing fines. Major violations by coaches can lead to sanctions, including prohibition from coaching or attending athletic activities and reimbursement of financial penalties assessed to the school.
