1. Call to Order

3. Presentations:

1. Science Department – Mrs. Stavropoulos

New theme is STEAM – Scientific Thinking Engages All Minds.

8th Grade uses 9th grade physical science, all grades use Discovery Techbook

All grade levels are enrolled in Accelerated Honors classes. 6th grade has 6th grade standards and 8th grade standards, 7th grade contains 7th and 8th grade standards. This year there are 3 8th Comprehensive classes and 3 9th grade Physical Honors classes. Next year 8th grade will be 9th grade Physical Honors, a high school credit class. Grading scale this year is an 80% (assessments)/20% (assignments) system

DATA: 8th grade cycle 1: County scored at 49%, Area 1 at 48%, Mrs. S at 67.9%; Physical Honors HS Course: District at 63%, Area 1 at 62%, Mrs. S scored at 79.8%.

6th and 7th grade data – at beginning of the year they took a GAP assessment. Seeing positive growth in data as compared to the bi-weekly assessments that the grade levels are taking.

2. Social Studies Department – Mr. Schlierer

6th grade – Mr. Rumaker – 6th Grade U.S. History covers Colonization of America through the Civil War. To Enhance Learning-Mr. Rumaker uses a variety of interactive activities and simulations. He works closely with ELA with writing, as well as with the Engineering teacher to complete cross curricular assignments. Data: 6th

Grade U.S. History has a district midterm (Dec.) and final exam (May).

- 2017-2018-Midterm-ELMS had the highest school average for the district and was 13 points above the district average.
- 2017-2018-Final Exam-ELMS was the third highest average and was 12 points above the district average.
- 2018-2019-Final Exam-ELMS was the second highest average and was 9 points above the district average.
- East Lake's scores for 6th grade U.S. History are <u>#2</u> in the district.

7th Grade – Mrs. DeTurk - 7th Grade Civics covers government topics including citizenship, the Constitution, branches of government, laws, voting, etc...

To enhance learning-students analyze historical documents, perform skits, use graphic organizers to organize new content, and complete other various activities in small groups to collaborate with new content.

District Cycle Assessments-

- Students take 3 Pinellas County Cycle Assessments at the end of each term.
- Cycle 1 Assessment(October)-ELMS <u>80.2%</u> average versus district average of <u>69.2%</u>. <u>EOC State Scores</u>:
- 2014-2015 ELMS <u>98%</u> passing-district <u>63%</u>.
- 2015-2016 ELMS <u>98%</u> passing-district <u>64%.</u>
- 2016-2017 ELMS <u>99%</u> passing-district <u>64%</u>.
- 2017-2018 ELMS <u>100%</u> passing-district <u>66%</u>, and state average of <u>71%</u>.

2018-2019 ELMS 99% passing-district 68%, and state average of 71%.

8th Grade – Mr. Schlierer – World History covers the agricultural revolution, Mesopotamian civilizations, Ancient Egypt, Israeli, Indian, Chinese, Mesoamerican, Greece, Rome, and Finance Park.

- To Enhance Learning-Mr. Schlierer uses evidence-based writing, hands on activities, and a college level research project (National History Day).
- Mr. Schlierer works closely with Mrs. Dobes (ELA) with reading and writing skills so they both can be consistent in what they teach the students and how they are assessed.
- 8th Grade World History has a district midterm (Dec.) and final exam (May).
- 2017-2018-Midterm-ELMS had the highest school average for the district and was 16 points above the district average.
- 2017-2018-Final Exam-ELMS scored a <u>82%</u> average, versus the district average of <u>62</u>%.
- 2018-2019-Final Exam-ELMS scored a <u>72%</u> average, versus the district average of <u>61</u>%.
- Sent students to both the state Geography Bee and to state National History Day for the last 2 years!
- Next year adding a Pre-AP class as a pilot school. Entrance into the course will be based on Reading and Writing scores.

- Presentation and Vote on A+ Recognition Funds committee and staff, through the voting process, has voted that the A+ money should be awarded to all staff members on campus during the 2018-2019 year. Any staff members that left had to notify Mrs. Huzar no later than 10/31/19 of the intention to be included in the disbursement. (All staff who left has done so.)
- 2. Vote to distribute monies is as follows: Admin, Guidance, Staff, and Instructional 1 equal share; Any other person working on campus in 2018-2019 (social worker, psychologist, nurse etc.) will receive a percentage of 1 share based upon time on campus.
